


9. This contract is hereby modified as follows:



The modified contract between the Mississippi Department of Education and Jimmy L. Hopkins for the purpose to continue duties as Conservator for the Hazlehurst City School District in Mississippi and to extend the end date of the contract from December 31, 2011 to June 30, 2012.
